## Application to keep more than two Dogs - Section 26 Exemption

Section 3(2)(2) of the City of Armadale's Dog Local Law prescribes in the First Schedule a limitation on the number of dogs that can be kept at a property. For all properties with an area of land less than $4,000 \mathrm{~m}^{2}$ an application to keep more than two dogs is required. A non-refundable application fee of $\$ 150$ is payable at the time of application.

By completing this application you will be applying for an exemption to be granted by the City of Armadale, as provided in section 26 of the Dog Act 1976 (as amended), in order to permit you to keep the dogs referred to in this application. Once permission is granted it will only be for the dogs listed in the application. Permission is not transferable if an approved dog is no longer living at the property and if you acquire a new dog, a new application will be required for each additional dog.
