# **Noise Investigation Request**

Should you wish to lodge a noise investigation request, please complete and return the enclosed `Noise Investigation Request Form' and accompanying `Log Sheets', so that the City can investigate your noise concerns.

It is important that you accurately record the noise nuisance as it affects you, providing as much information as possible. This information should also identify the source of the noise (at least the property address). It is recommended that you record the noise disturbances on the attached `Log Sheets' for the time period specified for that particular type of noise. This information will then be used to determine the nature of the noise and possibly identify a pattern of the times and days the noise typically occurs. Details provided will then assist the Environmental Health Officer to investigate your noise issue.

### **Enclosed in this package:**

- 1. Noise Investigation Request Form (to be completed and returned)
- 2. Log Sheet(s) (to be completed and returned, minimum of 14 days worth to be logged)

### Please Note:

The City receives a large number of requests relating to noise issues and these are dealt with in order of priority.

In some cases legal action may be necessary to a resolve a noise problem. In such cases the evidence of persons affected by the noise may be vital to achieving a successful outcome. Anyone making a noise complaint should be aware that they may be required to give evidence in Court should the need arise.

A mediation service is provided by the Citizens Advice Bureau and may be recommended by the City.
