

2018/2019 RATES COMPETITION – PAID IN FULL

TERMS AND CONDITIONS

1. This competition is being run by the City of Armadale, 7 Orchard Avenue, Armadale WA 6112 ('The City').
2. By entering this competition entrants agree to abide by these Terms and Conditions.

Who Can Enter

3. The competition is open to current ratepayers of the City of Armadale who pay their 2018/2019 rates in full by the due date stated on their Annual Rates Notice.
4. The entry will automatically be disqualified and ineligible if any payment is dishonoured by the financial institution concerned for any reason.
5. Councillors, staff employed by the City and their immediate family members are ineligible to enter the competition.
6. Government bodies and their related agencies, commercial property ratepayers and sponsoring organisations are ineligible to win. Rates exempt properties are also ineligible.

How to Enter

7. The competition will commence with the release of the 2018/2019 rate notices on 6 August 2018 and close at 4.45pm on 14 September 2018.
8. Entries will only be valid once they have been received and receipted by the City by the closing date and time. The City accepts no responsibility whatsoever for late, lost or misdirected entries, whatever the cause.

How to Win

9. The prize draw will take place on 17 September 2018 at 10am (Perth Time) at the City of Armadale Council Offices at 7 Orchard Avenue, Armadale.
10. Five winners will be randomly drawn from a computer generated list of ratepayers who have met the criteria in Clause 3 of the Terms and Conditions.
11. An additional five reserve winners will be chosen who will be substituted in the order in which they are drawn for any winner whose payment is subsequently dishonoured.
12. Decisions made by City Officers in regard to the awarding of prizes is final and no debate will be entered into.
13. The City reserves the right to verify the validity of entries and to disqualify any entry that is not in accordance with the competition Terms and Conditions or any entrant that interferes with the entry process.
